# Ride and Tell Gallery Contest Rules RM Rider Exchange – Rocky Mountain ATV/MC Blog

## 1. Who Can Enter:

Participants must be at least 18 years of age or the age of majority at their primary residence and have lawful access to the internet and a valid email address. Participants must be legal residents of the United States of America, Australia or Canada. Rocky Mountain ATV/MC employees as well as their family members or any persons living in their household(s) are ineligible. Proof of age and residence may be requested and must be supplied before prizes are awarded.

## 2. How to Enter:

No purchase is necessary. To enter, you must submit a photo to the Ride and Tell Gallery using the entry form located at RM Rider Exchange, the Rocky Mountain ATV/MC blog. You can also enter by sharing your photo on Twitter or Instagram with the hashtag #RideAndTell or by uploading your photo to the Rocky Mountain ATV/MC Facebook page wall with the hashtag #RideAndTell. If you post your photo on Facebook, Twitter or Instragram, you must change the photo's privacy settings to public so that it is viewable by Rocky Mountain ATV/MC. By submitting a photo through the RM Rider Exchange entry form or by using the #RideAndTell hashtag, you provide Rocky Mountain ATV/MC a non-exclusive, perpetual license to display your photo on Rocky Mountain ATV/MC's social feeds and blog galleries.

All entries must be received by September 15, 2014 at 11:59 pm MDT. Photo submissions after this time may be placed in the Ride and Tell Gallery, but they will not be considered entries for the Ride and Tell Gallery Contest. You are only allowed one entry regardless of the number of photos you submit. If a participant is suspected of using multiple email addresses in order to create multiple entries, all associated entries will be disqualified.

### 3. Winner Selection:

The winner will be selected at the end of the contest period by employees of Rocky Mountain ATV/MC using their best discretion. While voting on photos is part of the functionality of the Ride and Tell Gallery, voting results are not a requirement for the winner to be chosen in the Ride and Tell Gallery Contest. Once the winner has been selected, they will be notified by email. After Rocky Mountain ATV/MC has received a valid shipping address from the winner, the prize will be shipped. If there is no response from the winner by September 21, 2014 at 11:59 pm MDT, their prize will be forfeited without any compensation and awarded to an alternate winner.
